GENERAL ORDER No. 2008-07

In accordance with the Guide to Judiciary Policies and Procedures, Volume 1, Chapter 7, Part J, 2.6., unclaimed fund balances less than \$25 and balances for which an owner or rightful claimant cannot be determined should be transferred to the general fund receipt account for forfeitures of unclaimed moneys (106000). 
