

**Minutes of the
Federal Practice Committee Meeting

1. CALL TO ORDER

The Federal Practice Committee for the U.S. District Court for the District of Nebraska convened at 12:00 p.m. on Tuesday, May 12, 2009, in the Chambers of Judge Laurie Smith Camp in Omaha, Nebraska. Judge Laurie Smith Camp called the meeting to order.

2. INTRODUCTION OF ATTENDEES

3. APPROVAL OF PREVIOUS COMMITTEE MINUTES

The minutes of the meeting held August 15, 2008, were approved.

4. FEDERAL PRACTICE COMMITTEE BUDGET

Terry Brownfield reported on the status of the Federal Practice Fund. ([See attachments 1 and 2](#)). Brownfield is exploring opportunities for greater interest yield on the funds.

5. REPORT FROM THE CLERK OF COURT

Clerk Denise Lucks reported on the state of the docket ([see attachment](#)), and on the attorneys who have volunteered to accept IPF cases ([see attachment](#)).

6. COURTROOM TECHNOLOGY SEMINAR

David Stickman reported on the Courtroom Technology Seminar held on March 13, 2009, which was deemed a success by attorneys and staff in attendance. Light refreshments for the seminar were provided through the courtesy of the Federal Practice Committee and the Federal Practice Fund.

7. SCHEDULE AND PROPOSED REVISIONS TO THE COURT'S LOCAL RULES/ADMINISTRATIVE PROCEDURES

Mary Buckley, judicial clerk and chair of the Court's Local Rules subcommittee, reported on the schedule for revisions of local rules. Comments from lawyers are solicited and should be directed to Susie Cordero (susie_cordero@ned.uscourts.gov) on or before June 8, 2009. The Local Rules subcommittee and the Docket and Local Rules Committee will review and consider the suggestions and recommend proposed amendments to the Judicial Council for its October 30, 2009, meeting.

8. REPORT FROM THE JUDGES

Chief Judge Bataillon reported:

- A. There is once again pending in Congress a bill to authorize a fourth (temporary) judgeship for the district of Nebraska.
- B. Substantial improvements to the North Platte Courthouse are expected in connection with GSA's recent receipt of "stimulus" funds.
- C. The Court will welcome designated representatives of the bar at its strategic planning session on July 27, 2009.
- D. The Court's new interim U.S. Marshal is Karen Thomas.
- E. Attorneys serving on the Committee, including subcommittees, are encouraged to meet on their own initiative.

Judge Smith Camp reported:

- A. The 2009 Eighth Circuit Judicial Conference is for judges only. (Judge Bataillon noted that a request for funding for the conference may be circulated to members of the Federal Practice Committee's Budget Committee, despite the fact that this conference does not involve attorney participation. He recognized the concerns involved with such a request).

The 2010 conference, open to lawyers, will be in Minneapolis on August 11-13, 2010.

- B. The re-enactment of the Trial of Standing Bear, presented at the Hruska Courthouse following the Federal Practice Committee meeting, and the permanent display commemorating Ponca Chief Standing Bear, were made possible through the support of the Federal Practice Committee and its allocation of funds for these historic community outreach projects. Judge Smith Camp distributed several handouts with history of the Ponca Tribe, providing background for the afternoon's events.
- C. The Federal Practice Committee was encouraged to consider planning for continuing education programs, and to explore ways to ensure CLE credit for such programs.
- D. Professor Mark Scherer is working on a history of the U.S. District Court for the District of Nebraska, covering the first 100 years or so, and the book is expected to be completed in late 2010 or early 2011

9. ADJOURNMENT

The Committee adjourned at 1:30 p.m. The next meeting of the Committee will be scheduled for the fall, likely in connection with the NSBA conference.
