

## Office of Dispute Resolution, Nebraska Mediation Center, and Related Links

In 1991, the Nebraska Legislature passed the Nebraska Dispute Resolution Act to promote and develop the practice and use of mediation in Nebraska. It created the Office of Dispute Resolution (ODR) in the Administrative Office of the Courts and Probation to oversee the development and implementation of the Nebraska Dispute Resolution Act. An Advisory Council comprised of representatives from diverse backgrounds (the judiciary, the bar, the church, mental health, education, social services, and others) advises the ODR. The regional non-profit mediation centers are private, nonprofit corporations approved by and receive funding from the ODR. Centers receive additional funding from a variety of public and private sources to support their work in mediation and restorative justice.
