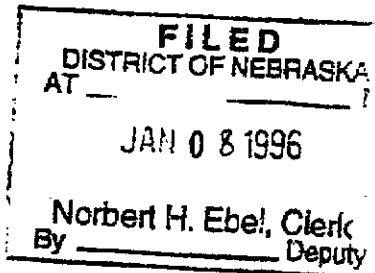


IT IS ORDERED:
