GENERAL ORDER 02-02

To equalize the docket between Judge Kopf, Judge Bataillon and Judge Smith Camp,

IT IS ORDERED that:

- 1. Effective immediately, the criminal and civil cases on the following list are transferred from Judges Kopf and Bataillon and assigned to Judge Smith Camp.
- 2. Omaha magistrate judges shall be assigned to the transferred cases in accordance with the standard practice; that is, Judge Jaudzemis is assigned to all civil cases transferred to Judge Smith Camp and Judges Jaudzemis or Thalken will be randomly assigned to the criminal cases transferred to Judge Smith Camp if such cases have not already been assigned to an Omaha magistrate judge.
- 3. The original of this order shall be filed as a standing or general order and placed on the Web. A copy of this order shall be placed in all the court files of all transferred cases. Copies shall be mailed to all counsel of record in the transferred cases.
