IT IS ORDERED:

On June 30, 2011, the United States Sentencing Commission voted to give retroactive effect to a proposed permanent guideline amendment involving crack cocaine offenses. The effective date of this retroactive effect and changes to §1B1.10 (Reduction in Term of Imprisonment as a Result of Amended Guideline Range), the policy statement governing retroactivity, is November 1, 2011.

With the assistance of the Sentencing Commission and this court's probation office, the court has identified offenders who may be eligible to file motions under 18 U.S.C. § 3582(c)(2) to reduce their sentences under the retroactivity guideline. A list of these offenders and their case numbers is attached to this general order. To facilitate the processing of any motions that might be filed pursuant to the retroactivity guideline, the clerk of the court is hereby directed to download from CM/ECF onto CDs the following documents for each offender identified:

1. Indictment, including any superseding indictment;
2. Plea agreement;
3. Judgment and commitment;
4. Statement of reasons;
5. Any Rule 35 motion;

6. Revised presentence investigation report; and
7. Any amended judgment and commitment filed following a Rule 35 hearing.

These CDs are to be delivered to the district's United States Attorney and the Federal Public Defender for review. If documents in an offender's case are sealed, the Federal Public Defender is hereby ordered not to release the documents to anyone other than counsel appointed to represent that offender in filing a motion to reduce sentence pursuant to the retroactivity guideline.
